TAX CREDITS OF CHARITABLE GIVING HOW TAX BENEFITS ADD UP

The first \$200 you donate is eligible for a federal tax credit of 15% of the donation amount and a 10% tax credit from the province. After the first \$200 the federal tax credit increases to 29% and the provincial tax credit increases to 21% over \$200.
